#### Dear all,

We are just three weeks away from our Fall 2024 Census Day. As you may have seen via our weekly enrollment reports (hopefully your department/division/unit heads are sharing this weekly information) our headcount and FTE are up a bit (exact numbers won't be complete until the Oct. 15 census). This is good news as we work to make the climb back to and ultimately beyond our pre-pandemic numbers. Recruitment for the 2025-26 academic year is underway and I thought folks might be interested in a glimpse at what is underway as we, together, make the most of what we are especially good at – interpersonal connection.

In addition to weekly individual prospective student visits and tours (40+ and counting since August) a number of on-campus group opportunities are scheduled.

Staff and faculty have been and continue to participate in four Hispanic Youth Leadership Symposium programs in Twin Falls (Sept. 17), Pocatello (Sept. 24), Moscow (Oct. 15), and Boise (Oct. 30); as well as our ever-popular LC Presents programming.
